Release and Waiver of Liability, Assumption of Risk, and Indemnity and Parental Consent Agreement ("AGREEMENT") and Photo Release

IN CONSIDERATION of being permitted to participate in any way in the ALL AMERICAN INDOOR SPORTS athletic/sports activity ("Activity") I, for myself for personal representatives, assigns, heirs, and next of kin:

1. ACKNOWLEDGE, agree, and represent that I understand the nature of athletic/sports Activities and that I am qualified, in good health, and in proper physical condition to participate in such Activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the Activity.
2. FULLY UNDERSTAND THAT: (a) ATHLETIC/ SPORTS ACTIVITIES INVOLVE RISKS AND DANGERS OF SERIOUS BODILY INJURY, INCLUDING PERMANENT DISABILITY, PARALYSIS, AND DEATH ("RISKS"); (b) these Risks and dangers may be caused by my own actions or inaction's, the actions or inaction's of others participating in the Activity, the condition in which the Activity takes place, or THE NEGLIGENCE OF THE "RELEASEES" NAMED BELOW; (c) there may be OTHER RISK AND SOCIAL AND ECONOMIC LOSSES either not known to me or not readily foreseeable at this time; and I FULLY ACCEPT AND ASSUME ALL SUCH RISKS AND ALL RESPONSIBILITY FOR LOSSES, COSTS, AND DAMAGES I incur as a result of my participation or that of the minor in the Activity.
3. HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE ALL AMERICAN INDOOR SPORTS, INC, their respective administrators, directors, agents, officers, members, volunteers, and employees, other participants, any sponsors, advertisers, and, if applicable, owner and lessors of premises on which the Activity takes place, (each considered one of the "RELEASEES" herein) FROM ALL LIABILITY, CLAIMS, DEMANDS, LOSSES, OR DAMAGES ON MY ACCOUNT CAUSED OR ALLEGED TO BE CAUSED IN WHOLE OR IN PART BY THE NEGLIGENCE OF THE "RELEASEES" OR OTHERWISE, INCLUDING NEGLIGENT RESCUE OPERATIONS AND I FURTHER AGREE that if, despite this RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND IDEMNITY AGREEMENT I, or anyone on behalf, makes a claim against any of the Releasees, I WILL INDEMNIFY, SAVE, AND HOLD HARMLESS EACH OF THE RELEASEES from any litigation expenses, attorney fees, loss, liability, damage, or cost which may incur as the result of such claim.
4. ACKNOWLEDGE AND AGREE that my and/or, if applicable, my minor child's participation in programs offered may give rise to the transmission of various illnesses, including the common flue and the novel coronavirus (COVID-19) , whether from other participants or from ALL AMERICAN INDOOR SPORTS, INC. staff or other individuals. I specifically agree, on behalf of myself, and, if applicable, my minor child, to assume the risk of contracting any and all illnesses (including personal injury, disability and death) resulting from my or, if applicable, my minor child's presence at ALL AMERICAN INDOOR SPORTS, INC. or my minor child's participation in programs offered, whether allegedly resulting from my negligence or the negligence of ALL AMERICAN INDOOR SPORTS, INC. and/or its staff. I further agree to promptly notify ALL AMERICAN INDOOR SPORTS, INC. if I or my minor child experience symptoms of a communicable illness or virus or if I have been diagnosed with a communicable illness or virus.

GRANT TO ALL AMERICAN INDOOR SPORTS, INC AND ITS SUCCESSORS AND ASSIGNS, THE IRREVOCABLE, PERPETUAL, ROYALTY FREE, WORLDWIDE, SUBLICENSABLE AND UNRESTRICTED RIGHT TO USE AND PUBLISH MY NAME, VOICE, LIKENESS, IMAGE, ANY PHOTOGRAPHS OF ME, OR ANY MATERIALS IN WHICH I MAY BE INCLUDED, FOR EDITORIAL, TRADE, ADVERTISING, AND ANY OTHER PURPOSE AND IN ANY MANNER AND MEDIUM; and to alter and composite the same WITHOUT RESTRICTION AND WITHOUT MY INSPECTION OR APPROVAL. I hereby release All American Indoor Sports from all claims and liability relating to any of the forgoing, including but not limited to any claims based on rights of privacy or publicity.
